


**Space Requirements for Inflatable Caterpillar/Butterfly Tube**

- The inflatable is 8 feet wide, 56 feet long and 14 feet high. It weighs about 350 lbs.
- We require 5 feet on either side, and 6 feet on either end, which makes the space required about 68 feet long by 20 feet wide. The caterpillar has a slight curve to it.
- People enter and exit through either end of the inflatable.
- There are several exits along the tube. Occupants are never more than 6 feet from an exit.



- The site should be clear of power lines and overhanging branches.
- The site needs to be fairly level.
- A grassy area works best, but concrete or asphalt will also work.
- Make sure there are no underground irrigation pipes, telephone cables or electric cables close to the perimeter of the inflatable. We use either 12" stakes or sand bags to secure the inflatable.
- Sprinkler heads on sprinkler systems should be well marked.
- Timed irrigation sprinkler systems should be turned off.
- A standard 110 volt outlet within 50 – 100 feet is required. The outlet should be at least 20 amps. It is best if the outlet not be shared with other large equipment. Lighting for night time operation requires an additional 10 amps.
- For rentals we set up on grass or indoors only.
- **Climb for Fun, Inc. reserves the right to refuse rental if we deem the site to be unsafe or likely to damage or soil our equipment.**

## **Safety Rules**

Even though this inflatable is safe, there are still a some safety rules that we follow. To reduce the likelihood of an injury, we will be sure that the people in the inflatable at any given time are of similar weight and size. The number of participants in the bouncer will be kept to a reasonable level.

Personnel in charge of the inflatable will enforce the following safety rules.

- Adult supervision will be required at all times.
- Persons not following the safety rules will be asked to leave the inflatable.
- Participants should remove shoes, sharp objects, and eye glasses before entering.
- All participants must empty their pockets before entering. Climb for Fun, Inc. is not responsible for articles lost during the operation of the inflatable.
- Participants will be grouped according to age and size.
- Tired children will be removed from the inflatable.
- There will be no flips, piling on, fighting or wrestling.
- We will not allow running and/or bouncing against the walls.
- There will be no running or jumping through the door.
- Participants may not climb or hang from the interior or exterior of the inflatable.
- We will not allow bouncing off the entrance ramp or outside of the inflatable.
- No **GUM**, food, drink, or candy is allowed in or around the inflatable.
- We will not operate the inflatable if the wind is above 20 mph
- Participants should not sit or lay down while others are bouncing around them, as a jumping participant could fall down on top of a sitting or lying participant.
- **No silly string, or any other substance is allowed in the inflatable.** Violation of this rule will result in a significant damage charge.
